

# MINUTES of the Ordinary Meeting held on Tuesday 28th January 2025

25.0 PUBLIC REPRESENTATIONS- the following items were raised:

• A drainage issue has been identified: down the road from Manor House. The road has been washed away, and the ditch at the bottom is filled. Water continues to flow down the main road, filling the sewer near Low Pastures and the adjacent field, despite the grates being cleared.

Action: Write to Bolton Estate regarding the culvert. Contact North Yorkshire Council (NYC) to obtain maps of the drainage system.

- Hargill Road: Additional water flow noted.
- Yorkshire Water Sewerage System: Yorkshire Water has failed to improve the sewerage system despite a promised upgrade.

Action: Write to Yorkshire Water regarding concerns over the sewerage system.

• Village Tap in the middle of the green: has burst due to freezing weather.

Action: Cllr Shields to fix and insulate the tap on the green.

- Parking Concerns: Issues raised regarding parking in the village.
- **High Green Protection:** Discussed the protection of the Village Green; wooden posts to be considered.

Action: Clerk to look at costings for posts on Village Greens and Cllr Jordan to follow up on the installation of the knee rail fence.

- 25.3 MINUTES OF MEETING HELD ON TUESDAY 10<sup>TH</sup> DECEMBER 2024-were approved and signed as a true record.
- 25.4 NOTICE OF VACANCY CLLR R STRONG (THIS VACANCY CAN BE FILLED BY CO-OPTION)- An application was received from Mr. Allan Workman, who has 15 months of volunteering experience assisting with national park footpaths and railway maintenance. The Council resolved to



accept this application and co-opt Mr. Workman onto Redmire Parish Council, recognising the valuable experience in environmental conservation and community service that he brings to the Council.

Action: Mr Workman to complete the declaration forms and return to the Clerk.

  - a) Impact of funding shortfall on vital services.
  - b) Strategies to address financial deficits and advocate for fair funding.
  - c) Implications of the Government's spending review on future allocations.

Action: Clerk to write a letter to North Yorkshire Council raising concerns and objections.

### 25.10 NORTH YORKSHIRE HIGHWAYS & STREET LIGHTING

Monument Lamp Repair: The old wire is damaged and needs replacement, and the corroded box does not meet Health & Safety requirements. NYC suggested installing a new armoured wire to the light fitting at the top and running it to a



new communications box behind the bus shelter to ensure security. The Parish Council were informed that NYC have a more suitable glass lantern for the top.

**Street Lighting Review: NYC** inspected other street lighting for necessary upgrades or repairs. A Review of street lighting in the village by Cllr Jordan identified additional outages which have been reported to NYC.

NYC Highways: Attended to clear the drains on the main route through the village.

#### Agenda Item 25.7 summary

**North Yorkshire Council Funding Shortfall:** North Yorkshire faces a £6.5 million shortfall in funding following the latest local government funding settlements.

Rural Grants Cut: The axing of rural grants worth £14.3 million per year has significantly impacted the county.

National Insurance Costs: Increases in employer's National Insurance costs have added to the financial burden.

**Deputy Leader's Concerns:** Cllr Gareth Dadd has expressed disappointment with the financial settlement, highlighting the disadvantage faced by rural councils compared to urban areas.

**Spending Review:** The Government has pledged a spending review, with deprivation being a key driver for funding allocation. **Service Challenges:** The sparsely populated communities in North Yorkshire face higher costs for services such as home to school transport and social care.
