

DRAFT MINUTES OF THE ORDINARY MEETING OF REDMIRE PARISH COUNCIL HELD ON TUESDAY 12th AUGUST 2025

- **25.78 PUBLIC REPRESENTATIONS-** An update was provided regarding the recent works on the play areas. Work has commenced and is currently in progress.
- 25.79 APOLOGIES Apologies were received from Cllr Shields.
- **25.80 DECLARATION OF INTEREST-** None received.
- 25.81 MINUTES OF MEETING HELD ON WEDNESDAY 25TH JUNE 2025-approved and signed as a true record.

25.82 COMMUNITY CONCERNS REGARDING SHEEP SECURITY-

The Council noted ongoing concerns regarding livestock entering the village. While the matter falls outside the Parish Council's statutory remit, members discussed potential community-led approaches and the possibility of engaging with relevant landowners. Residents are encouraged to remain constructive and considerate in addressing the issue, recognising the complexities involved.

Action: Highways to be contacted to request if the installation of sheep warning signs would be possible; update to follow.

25.83 REPORTS

- a) Police Report- Noted (appendix).
- b) Update from meetings attended by Councillors- Cllr Houghton reported on the Leyburn Medical Practice (LMP) Patient Participation Group (PPG).

Following a community survey conducted 18 months ago, the need for a Minor Injuries Unit in Wensleydale was highlighted due to travel distances. Despite initial engagement, the proposal was declined by LMP. Funding has



instead been allocated to the Minor Injuries Centre in Catterick, which unfortunately does not address transport and rural access issues for Lower Wensleydale. The outcome was described as disappointing for the local community.

25.84 INSURANCE- The Council agreed to remain with the current insurer. Housing assets will be separated upon receipt of the relevant Land Registry deeds.
