- 25.93 MINUTES OF MEETING HELD ON TUESDAY 12TH AUGUST 2025-Approved and signed as a true record.

25.94 REPORTS

- a) Police Report- noted in the appendix.
- b) Upper Dales Health Watch Minutes- Noted.
- c) Update from meetings attended by Councillors- Cllr Houghton reported on discussions from the Leyburn Patient Participation Group (PPG) Annual General Meeting. A question was raised regarding the provision of minor injuries services. The medical practice expressed that they currently lack both the capacity and inclination to take on such services.

Concerns were also voiced about the extensive NHS appointment waiting lists. It was suggested that the PPG should play a more active role in lobbying for improvements and influencing strategies to help reduce waiting times. The group was encouraged to put forward constructive proposals to support this aim.

25.95 HIGHWAYS

a) A684 WENSLEY VILLAGE RESURFACING WORKS- North Yorkshire Council, will be undertaking resurfacing works at the above location. The works are currently programmed to commence on 25/09/2025 and will be carried out under a full road closure between the hours of 09:30-15:30 for a period of 10 working days.

25.97 PLAY AREA

a) Annual Inspection Report- The Council reviewed the report and will take any necessary action based on its findings. Ongoing maintenance by Pete Wheeler is to continue.

Action: Clerk to request that Mr Wheeler addresses the misaligned gate, which requires resetting to ensure proper closure and site security.

25.98 IT

- a) Windows 10 Support- it was noted that support for windows 10 stops on October 15th 2025.
- b) Windows 11 to note an upgrade is recommended to mitigate potential issues with RTI submissions and address existing security vulnerabilities. The current Council laptop does not meet the minimum system requirements for Windows 11.

25.99 LAND

a) Unauthorised Fencing on Village Green- Temporary fencing has been installed without permission, blocking pedestrian access and raising safety concerns. Complaints have been received, and public access to the green cannot be lawfully restricted under the Inclosure Act 1857 and Commons Act 1876.

Cllr Houghton abstained from commenting.

Action: Write a letter requesting removal of the fencing, citing relevant legislation. The draft will be circulated to Councillors for review.

25.100 FINANCE & GOVERNANCE

- a) **Internal Audit-** The Council resolved to appoint Clare Smith to complete the internal audit for 2025-26.
- b) New Assertion 10 in the Annual Governance and Accountability Return (AGAR) for Year Ended 31 March 2026 Digital and Data Compliance. The Council discussed the requirements of the newly introduced Assertion 10 in the AGAR, which relates to digital and data compliance. Members acknowledged the importance of ensuring that all Council systems,



- communications, and data handling practices meet current standards for security, accessibility, and transparency.
- c) Gov.uk Domain Consideration of Recommendation In light of the above, the Council considered the recommendation to transition to a .gov.uk domain to strengthen digital compliance and improve public trust. It was noted that a .gov.uk domain would support secure communications, reinforce the Council's official status, and align with best practice for public sector governance. Resolution: The Council resolved to obtain quotes for the setup and migration to a .gov.uk domain. This matter will be brought back to the next Parish Council meeting for further consideration and decision.
